

"Smash it - Fantasy Tennis" or "the application", is a fantasy tennis application with Live Score section to follow the results of the main ATP tournaments, also integrated in the application is a premium section where you can purchase advanced services and features. You can participate in the competition and join a private league or create a new one only after creating an account. The following conditions apply to all our applications.

Within the application you can purchase various additional features at a price clearly stated. The purchase of any additional feature (except for the elimination of advertisements, that lasts one year from the subscription moment) has immediate effect and is usable only for the tournament for which the purchase has been made; this means that any right deriving from the purchase of one or more additional features (advertisement elimination excluded) is automatically cancelled from the conclusion of the tournament.

Some of the additional features may be offered as an annual or monthly subscription with automatic renewal. In particular, the package called "Remove Advertising", provides an annual subscription at a cost of 4.99

The charge of any purchase made through the app is managed directly by the platforms (App Store for iOS and Play Store for Android) on which the app is distributed. Any requests for reimbursement or deactivation of the automatic renewal must be made through the platforms mentioned above.

Quazo srl is in no way responsible for any consequences due to the use of the services available in the application, whether free or paid, and offers no guarantee as to their operation, accuracy or availability.

Quazo srl reserves the right to terminate or suspend the provision of these services at any time without prior notice.

The user who registers is informed, pursuant to and for the purposes of Legislative Decree 196/2003 on privacy, that registration is free of charge and that by registering, Quazo srl will keep the personal data of the registered user in a form that allows identification of the interested party for a period of time not exceeding that necessary for the purposes for which they were collected or subsequently processed.

Quazo srl, in compliance with the provisions of art. 7 of Legislative Decree 196/2003 on privacy, hereby informs its users that they are entitled to the following rights:

1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet recorded, and their communication in intelligible form.

2. The interested party has the right to obtain the indication of

→ the origin of the personal data;

→ the purposes and modalities of the treatment

→ of the logic applied in case of treatment carried out with the aid of electronic instruments;

→ of the identification details of the owner, of the persons in charge and of the representative appointed according to article 5, paragraph 2;

→ of the subjects or of the categories of subjects to which the personal data can be communicated or that can come to know them in quality of representative designated in the territory of the State, of responsible or charged persons.

3. The interested party has the right to obtain

→ the updating, the rectification or, when interested, the integration of data;

→ the cancellation, the transformation in anonymous form or the block of the data treated in violation of law, including those of which the conservation is not necessary in relation to the purposes for which the data have been collected or subsequently treated;

→ certification that the operations in letters a) and b) have been notified, also as regards their contents, to those to whom the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate to the protected right.

The interested party has the right to oppose, in whole or in part

→ for legitimate reasons to the processing of personal data concerning him, even if pertinent to the purpose of collection; to the processing of personal data concerning him for the purpose of sending advertising materials or direct selling or for carrying out market research or commercial communication.

Concerning the above-mentioned users' rights, Quazo srl informs that personal data are necessary to allow access to the areas reserved to the management of the user's personal account. Failure to consent to the processing of personal data and/or failure to communicate it will not allow the user to register on Smash it - Fantasy Tennis. Users' personal data will not be communicated to third parties for purposes not allowed by law or without the express consent provided by the user at the time of registration. In addition, personal data may be communicated to the police or judicial authorities, in accordance with the law and after a formal request by these subjects. In these cases the agreement to the processing of the same is not necessary. The owner of the management of personal data, which will be managed in compliance with the law, is Quazo srl to whose e-mail address smashit.atp@gmail.it any variation of the same must be communicated. The user's personal data will only be used for purposes strictly connected to the use of the application.

At the time of registration, the user may grant Quazo srl permission to use the data for advertising and information purposes.

It is understood that in accordance with art. 7 D. Lgs. 196/2003 the user can at any time obtain, through a request to be addressed to smashit.atp@gmail.it, that their data will no longer be used for sending advertising material or receiving commercial communications from Quazo srl.
